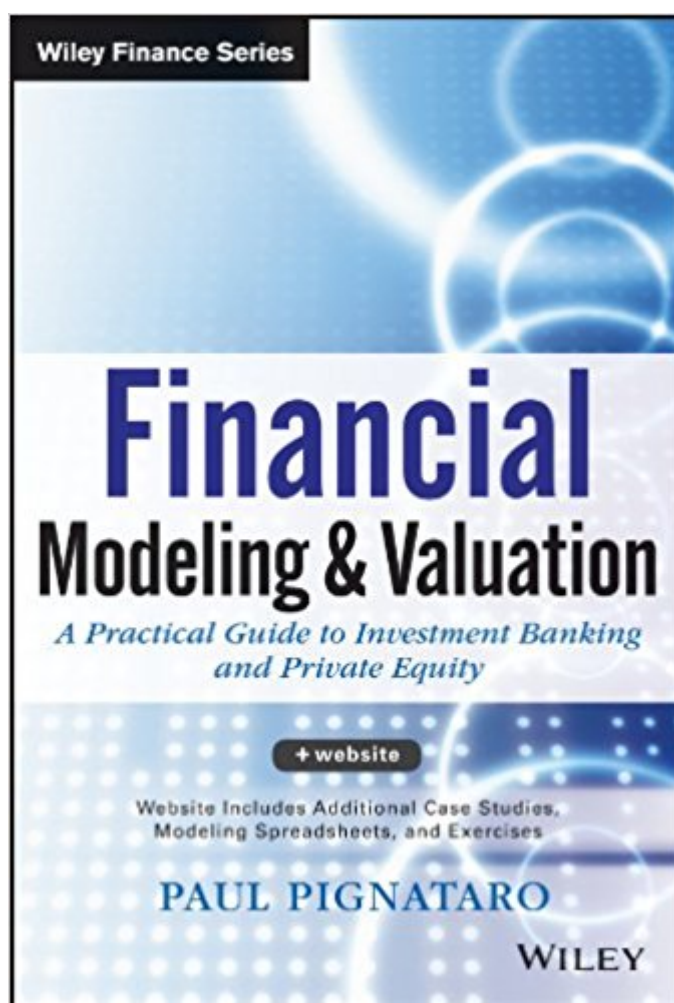

Financial Modeling & Valuation is easy to follow, even for Excel novices, as it clearly describes step-by-step how to build the model and you can follow along with the Excel template available at the publisher's website. At times, the book may take a long time to get through as it will go through every step and every formula used in the model, including which cells to link thru, and indeed if you have a lot of experience with Excel or financial modelling, you may find Joshua Rosenbaum's book more appropriate, as that includes M&A and LBO modelling as well as basic information on other Investment Banking and Private Equity. However if you are new to financial modeling, this book is a lot better at holding your hand. I would suggest getting both, but if you can only afford one, then the choice would depend on your level going in.

This book is a great tool for someone looking to learn how to build a full scale valuation of a company the same way it is done in Wall Street. The way it is written makes it very easy to follow if you have basic accounting knowledge you surprise yourself ending up by building a full model. Everyone having a serious intention to learn how investment banking and valuation methods are all about, this is a great place to start.
